3. Intended use or uses of the construction product, in accordance with the applicable harmonised technical specification, as foreseen by the manufacturer:

3.1 The intended use of the system Mulcol® Multifoam 2K is to reinstate the fire resistance performance of penetrations in walls and floors, as included in ETA 17/0977 and ETA 17/0831.

3.2 The conditions under which the system Mulcol® Multifoam 2K can be used are intended for indoor use, conditions: relative humidity $\geq$ than 85% RH, excluding temperatures below 0 °C, and without exposure to rain or UV (TR 024: 2019, model Z₁).

3.3 The provisions made in the ETA 17/0977 are based on an assumed working life of the Mulcol® Multifoam 2K for 30 years, provided that the conditions laid down in the manufacturer's datasheet and instructions for the packaging, transport, storage, installation, use and repair are met.

The indications given on the working life cannot be interpreted as a guarantee given by the producer, but are to be regarded only as a means for choosing the right products in relation to the expected economically reasonable working life of the works.
